### STROKE IN OREGON


- Stroke 4<sup>th</sup> leading cause of death in OR
- Leading cause of long-term disability
- 86,000 OR adults have had a stroke

### STROKE IN OREGON

- 7,762 hospitalizations due to stroke in OR
- \$32,723 Ave cost for stroke hospitalization, totaling almost \$254 mln
- Smokers 40% more likely to have a stroke
- Incident and death rates consistently higher among African American, American Indian/Alaska Native and Latinos

### STROKE IN OREGON



- Adults with HH income <\$20k four times more likely to have stroke than \$50k+
- OR adults in OHP nearly 3x more likely to have stroke

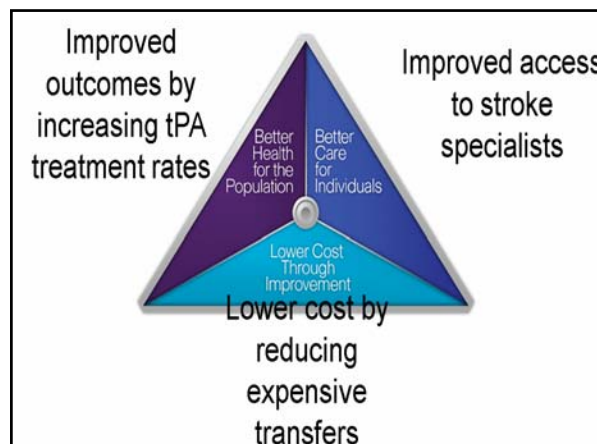
**We can prevent and treat stroke**

## STROKE CARE COMMITTEE

**The Director of the OHA shall appoint at least 10 members:**

- Two physicians who specialize in stroke care, one neurologist;
- One physician who specializes in emergency medicine;
- At least three hospital administrators, or designees:
  - At least one from a Comprehensive Stroke Center;
  - One from a certified Primary Stroke Center; and
  - One from a rural hospital that uses Telestroke;
- One nurse who is a stroke coordinator or who works in an emergency department and has experience treating stroke;
- One emergency medical services provider who works for a licensed ambulance service;
- One practitioner who specializes in rehabilitative medicine;
- One individual who has experience advocating for the care of stroke patients and who is not a health care provider.

## COMMITTEE CHARGE

**For the purpose of achieving continuous improvement in the quality of stroke care, the committee shall:**

- Analyze data related to the prevention and treatment of strokes;
- Identify potential interventions to improve stroke care; and
- Advise OHA on meeting objectives related to stroke care.

## STROKE DATA COLLECTION

### In Implementing the plan, the OHA shall:

- Designate a statewide or national stroke database to which hospitals submit stroke care data
- Comprehensive Stroke Centers and Primary Stroke Centers required to submit stroke data
- All hospitals encouraged to submit stroke data

## DATA SHARING & USAGE

### The Oregon Health Authority shall:

- Coordinate with partners to avoid redundant processes
- Use data to improve quality of stroke care in accordance with national guidelines
- Encourage info sharing, data trends & treatment developments among health care providers and CCOs
- OHA to submit bi-annual report to Oregon legislature
- All data is confidential & de-identified

## STROKE AND HEALTH REFORM

- Federal Affordable Care Act
  - January 1<sup>st</sup>, 2014
- Data Collection
  - Required Metrics for ACA = GWTC-Stroke Metrics
- Cover Oregon & Coordinated Care Organizations
  - All legal Oregon residents required to have health coverage beginning January 1<sup>st</sup>, 2014
  - Medicaid expansion up to 138% of FPL
